II. Discussion Items (9:20-9:55)



a. Internal Budget Reallocation (IBR) 22-23:01: Establishment of <u>Graduate and</u> <u>Career Testing Fund</u>, presentation by Alice Zhang; ASuop Director of Finance

Three main changes:

They changed the allocated budget originally made by Scout for 2021-2022 \rightarrow change in semiannual funding that is going to go towards Graduate and Career Testing Fund.

- Decrease from \$52,000 to \$40,000
- It is reasonable to move these funds based on other budgets

Deputy Director of Finance and DEI were also changed however they are estimates and they could change based on the hours.

Total expenditures went up by \$3,000 with the other changes and they shouldn't impact the overall budget due to the semi-annual funding.

Director Zhang explained Karen our outgoing Business Manager's role in the budgeting. She also clarified that semi-annual funding is a funding opportunity for the students and can be used for the functions of their clubs.

b. <u>Senate Committees Overview</u> and Discussion led by Senators Gandolfo-Gillapsy, Spaccarelli, and Torres

Last year, Senator Lorenzo served on Rules, Senator Torres on Finance and Senator Gandolfo-Gillapsy on Senate Selection. New senators can contact them with questions.

VP Tran asked the timeline on filling the seats in case of vacancies. Gillapsy explains that sometimes there are empty seats that come up. There isn't a specific timeline but try to fill that seat as fast as possible.

a. PN 22-23:09

VP Tran turned the floor over to President Zhong to outline the structure of nominations and Senate questioning



President Zhong introduced the Associate Justice of the Supreme Court nominee Ainsley Berryhill.

Ainsley is interested in staying involved which is the reason she applied for the position. She has previously worked with Lorenzo and Serena Young (previous pharm senator) and is familiar with the bylaws. She feels very passionate about helping in that particular area.




